## About the service

The Care Inspectorate regulates care services in Scotland. Information about all care services is available on our website at <u>www.careinspectorate.com</u>

The service registered with the Care Inspectorate on 15 February 2017.

The service provider, Collin Care Limited, operates seven additional nurseries in the west coast of Scotland. Glencoats Lodge Nursery is registered to provide a day care service to a maximum of 39 children, from babies to children not yet attending primary school. The service is situated within the Ferguslie area of Paisley, Renfrewshire. The accommodation offers three age defined playrooms as well as fully enclosed outdoor play areas to the front and rear of the property. The nursery has partnership status with Renfrewshire Council to provide places for children aged 3-5 years.

We check services are meeting the principles of Getting it Right for Every Child (GIRFEC), Scotland's national approach to improving outcomes and wellbeing for children by offering the right help at the right time from the right people. It supports them and their parent(s) to work with services that can help them. There are eight wellbeing indicators at the heart of GIRFEC: safe, healthy, achieving, nurtured, active, respected, responsible, and included, also known as the SHANARRI wellbeing indicators.

At this inspection we spoke with some children and six members of staff. We observed practice and checked documentation relevant to the inspection.

We carried out an unannounced inspection of this service on 23 and 24 October 2018 and gave feedback to the manager and depute manager at the end of the inspection.

## What people told us

Overall children were happy and content in nursery. They had nice relationships with staff. Younger children were settled and able to explore their surroundings independently while being supported by staff if needed. Older children were encouraged to form positive relationships with their peers, They were able to share their play with us and explored the outdoor play areas with confidence.

We had two care standards questionnaires (CSQs) completed and returned to us during our inspection. We also had five staff CSQs returned to us.

Overall all parents indicated they were happy with the quality of care their child received. Some additional comments from parents are included with this report.

## Self assessment

The service had not been asked to complete a self assessment in advance of this inspection. We looked at their own monitoring paperwork. These demonstrated their priorities for development and the quality of the provision within the service.

## Quality of care and support

#### Findings from the inspection

Confident children were nurtured by staff who supported them to make choices and form positive relationships with their peers. Children seemed to enjoy having visitors in nursery and wanted to play and have fun with us. Staff promoted self awareness and responsibility for children and this had resulted in a caring and inclusive space for children where they could safely express themselves.

Personal plans were in place for all children. Online learning journals were used by staff and parents had the opportunity to comment and provide information to help staff support children. This helped to engage parents in their child's learning. They had started to use floor book planning to record children's voices and experiences. We discussed their plans to develop these further as previous paperwork was not reflective of children's individual needs, learning and development was not easily tracked, nor the diversity of experiences provided by staff (see recommendation 1).

The variety and quantity of resources could be improved throughout the nursery but particularly within the 3-5 room where children would benefit from more challenge and opportunities to extend their learning including schematic play and Science, Technology, Engineering and Maths (STEM) experiences. Baby room staff should ensure that they plan and organise the playroom to encourage creativity using multi-sensory and natural resources. Staff have developed a sensory room however children would benefit from having similar resources in their 'main' playroom (see recommendation 2).

While children were for the most part, able to move freely between the indoor and outdoor space throughout the day, there were times when this was disrupted due to adult led activities. We discussed the pace of the day and how this could be improved so that children spent more time engaged in learning experiences. There were various opportunities for children to practice their independent living skills for example older children were able to become a 'buddy' for younger children transitioning into the 3-5 playroom.

Parents commented, "They take the time to get to know the child and parent. Feedback provided at the end of every session".

#### Recommendations

#### Number of recommendations: 2

1. The service should review and develop their paperwork relating to planning records to ensure that the information being recorded was meaningful, individualised and allowed effective monitoring of children's learning and development needs and progress.

This ensures care and support is consistent with the Health and Social Care Standards, which state that: 'I experience high quality care and support based on relevant evidence, guidance and best practice' (HSCS 4.11).

2. The provider should ensure that all children have access to, but not be limited to, imaginative, creative, schematic play, role play, explorative, messy and sensory and STEM experiences on a daily basis.

This ensures care and support is consistent with the Health and Social Care Standards, which state that: 'as a child, I can direct my own play and activities in the way that I choose, and freely access a wide range of experiences and resources suitable for my age and stage, which stimulate my natural curiosity, learning and creativity' (HSCS 2.27).

## Quality of environment

#### Findings from the inspection

The playrooms for children were bright and welcoming. Children were very confident and familiar with the routines within nursery. They were able to practice self help skills, for example by helping to set up the tables at lunch time. We discussed how some infection control procedures could be improved and staff took this on board.

There had been some changes to the layout within the 3-5 room which staff advised was due to following children's natural play choices by changing the book room into a 'feelings' area as they had recognised that some children needed a safe space to express themselves. This resulted in a cosy and calm space where children seemed to enjoy spending time.

The need to further develop each playroom's home corner was discussed during the inspection. Resources should be gathered to enrich each home corner so that they better represent the children's wider worlds and to create a space where they can make sense of their experiences through imaginative play. Staff should display aspects of children's home lives, including images and text, which celebrate the nurseries cultural diversity and to create an inclusive environment.

We discussed how increasing the diversity and quantity of resources would provide richer play experiences for children. Risk assessments were in place for all areas of the nursery. Children had some opportunities for engaging in risky play, particularly within the outdoor space. We discussed how this could be extended further and provide some more challenge for children.

The outdoor area was a valuable resource for the nursery. It had recently been extensively refurbished and because of fundraising by staff, parents and the local community they now had a wooden pirate ship and

castle for all ages of children to enjoy outdoors. We discussed how the service could develop the resources and range of experiences available to children now that the outdoor area was completed. They had also been involved in supporting the local community developing a 'Fairy Trail' through the park. Children really benefitted from having access to such a great resource on their doorstep.

## Quality of staffing

#### Findings from the inspection

There had been some changes to the staff team since the last inspection. All staff were registered or in the process of registering with the Scottish Social Services Council (SSSC). The new team worked well together and demonstrated a positive and inclusive approach. Staff engaged in professional dialogue and were able to share with us the changes they had made from the last inspection. They were keen to provide a good service for children and their families.

We observed staff supporting children to problem solve and resolve disagreements with their peers in a kind and caring manner. They had lots of fun with children and the positive loving relationships were clear to see. Children's everyday achievements were celebrated by staff. This helped to promote positive self esteem and confidence.

They recognised that they were on a learning journey and were fully committed to promoting positive outcomes for children. During the inspection we observed staff being responsive to individual children's needs and preferences. Children were cared for sensitively and respectfully.

The staff team should continue to develop their observation skills so that they are able to identify children requiring additional support to participate in the learning opportunities available. We discussed best practice documents and how they would provide staff with the tools to assess and evaluate their practice, enhance the quality of information being recorded, improve experiences for children and elevate their learning environment (see recommendations 1 and 2).

Parents commented, "I feel confident to speak to the staff about any concerns I have. Staff are always open to answer all questions".

These documents can be used as the starting point for evaluating practice and identifying areas for improvement, for example, the use of open-ended resources, different types of play, risky play and providing challenge. This will help the service to provide richer play experiences for all children.

2. The provider should consider staff accessing further training to improve and develop their existing skills, facilitate children's learning and improve the quality of information being recorded.

## Quality of management and leadership

#### Findings from the inspection

The manager was keen to ensure that children were well taken care of and that parents were kept informed of any changes in care or within the service as appropriate. This had helped facilitate positive relationships with parents who were able to become involved in the nursery and make a positive contribution. The management team had made good progress in making improvements to all aspects of the service since the last inspection. They recognised that there was further work to do and were keen to make a difference. Although the provider submitted a notification about an incident after the inspection they had not been aware of their responsibilities regarding notifications (see requirement 1).

The management team provided a nurturing and supportive environment for staff as well as children. This meant that staff were fully committed to the service's development and progression. While some areas for improvement and development had been identified by the service we discussed how these could be more focussed and planned over both short and long term timescales. By creating a plan of self evaluation and monitoring, staff could use the tools as the starting point on their journey of developing the service. This would be a positive guide for the service to evaluate the impact of the proposed changes and involve staff as well as parents and children in taking the developments forward (see recommendation 1).

Staff had the opportunity to attend a variety of training courses. They were also encouraged to evaluate any training that they had attended. The influence this training had on outcomes for children using best practice guidance had not been fully explored. Opportunities to enhance staff practice and progression could be improved (See recommendations 2 and 3).

Parents commented, "Very happy with service".

This ensures care and support is consistent with the Health and Social Care Standards, which state that: 'as a child, I have confidence in people because they are trained, competent and skilled, are able to reflect on their practice and follow their professional and organisational codes' (HSCS 3.14).
